- 2. Description and Scope of One Health Activities:

Aequor has developed a large portfolio of "green," non-toxic chemicals that can replace toxic, ineffective biocides and antibiotics to control bacteria and fungi. Twenty-five of Aequor's chemicals are approved under the U.S. Toxic Substances Control Act (TSCA) and are validated by USDA, DOE, NASA and several private labs to remove contamination from all surfaces: farm, community, household, hospital – and environmental, including on the surface of water itself. Aequor's chemicals remove biofilm in minutes and prevent its formation for days. Several also kill the antimicrobial-resistant (AMR) bacteria, fungi alone, in combination with each other, and in combination with obsolete antibiotics, like Penicillin, "potentiating" them to kill the AMR pathogens.

9. Brief History of Your Organization's One Health Involvement

From 1992 to 2008, Marilyn Bruno was an Economic Officer in the State Department Foreign Service. She participated in conferences at the UN FAO Codex Alimentarius (food safety, minimum pesticide levels, food security), Convention on Biological Diversity (environmental impacts of biocides and antibiotics), Cartagena Protocol on Biosafety (international food safety), and was the State Department point person for pandemic threats during the bird and swine flu epidemics. Dr. Bruno met with stakeholders at the OIE, FAO, WHO and other organizations and government agencies developing the framework for sharing information among the three pillars of health (environment, animals and people), and creating mechanisms for all governments to rapidly share information in order to identify the origins of epidemics and coordinate the containment and treatment.

The emergence of antimicrobial-resistant (AMR) pathogens has heightened the need for these frameworks, which were called "One Health" in 2007. Dr. Bruno founded Aequor, Inc. in 2006 with Dr. Cynthia Burzell, Marine and Medical Microbiologist, to develop remedies for bacterial and fungal contamination and infection – including AMR -- in environmental, animal and human vectors. She retired from the State Department in 2008 to become CEO of Aequor.

Drs. Burzell and Bruno have spoken about One Health at every conference they have participated in for over eleven years (some of which are listed above) and have included a description of One Health on the Aequor website since its creation in 2008. Dr. Bruno was honored to be invited to speak at the United Nations General Assembly High Level Meetings on AMR in 2016 and applauds all efforts to explain the critical importance of the One Health goals.
